If any potential winner is considered a minor in his/her jurisdiction of residence, Declaration/Release must be signed by his/her parent or legal guardian and such Prize will be delivered to minor's parent/legal guardian and awarded in the name of parent/legal guardian. In the event (i) the Liberty's inability to contact Winner within five (5) calendar days of first notification attempt, (ii) any Prize or Prize notification is returned as undeliverable, (iii) any potential winner rejects his/her Prize, or (iv) noncompliance with these Raffle rules and requirements; then such Winner may be disqualified and the Prize will be forfeited, and an alternate Winner will be selected from all remaining eligible Participants. All issues and questions concerning the construction, validity, interpretation and enforceability of the Rules, or the rights and obligations of the parties hereto in connection with this Raffle shall be governed by: (i) the laws of the Commonwealth of Pennsylvania, without regard for conflict of laws principles, for Participants located in the continental United States and District of Columbia, and (ii) the laws of the Province of Ontario and, where applicable, the federal laws of Canada, without regard for conflict of laws principles, for Participants located in Canada. Each of the parties hereto hereby accepts and irrevocably consents to all proceedings taking place in the exclusive jurisdiction and venue of the federal, state or local courts in and for (i) Allegheny County, Pennsylvania for Participants located in the continental United States and District of Columbia, and (ii) the state or federal courts located in Toronto, Ontario and shall not contest or challenge the personal jurisdiction or venue of such courts, for Participants located in Canada. If any provision of the Rules are found to be invalid or unenforceable by a court of competent jurisdiction or appointed arbitrator, such determination shall in no way affect the validity or enforceability of any other provision herein. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE PARTIES HERETO EXPRESSLY WAIVE ANY RIGHT TO TRIAL BY JURY IN ANY ACTION, SUIT OR PROCEEDING ARISING IN OR IN CONNECTION WITH THE RULES AND THE TRANSACTIONS CONTEMPLATED HEREIN.

- **11. PUBLICITY. USE OF LIKENESS.** Participants agree to be available for publicity purposes without compensation. Accordingly, Participants agree that by participating in the Raffle and/or accepting the Prize, Liberty may use their names, images, company logos, and company names in advertising and promotional material and to a photographer being present to document the winning experience.
